

1. WIFE OF BLANCO TRIUMVIRATE MEMBER MARIO HEBER WAS INTERRED MORNING OF SEPTEMBER 6 AT MONTEVIDEO MAIN CEMETERY. CROWD OF SEVERAL HUNDRED ATTENDED, INCLUDING ALL LEADING BLANCO OPPOSITION ACTIVISTS, A NUMBER OF RETIRED MILITARY WHO ARE BLANCO SUPPORTERS AND A SMATTERING OF COLORADO LEADERS. (TWO OF THE THREE COLORADO TRIUMVIRS WERE OUT OF TOWN). ONLY RECOGNIZED GOU FIGURE WAS FONOFF PROTOCOL CHIEF ROMERO, WHO OWNS APARTMENT IN SAME BUILDING WITH HEBER FAMILY.

2. EMBASSY WAS REPRESENTED BY POLOFFS YOULE AND SHAW; BRITISH WERE ONLY OTHER DIPLOMATIC MISSION IN ATTENDANCE. AFTERNOON OF SEPTEMBER 6 INTERIOR MINISTER GENERAL HUGO LINARES BRUM IN PRESS CONFERENCE ON HEBER POISONING CASE STRESSED IN UNUSUALLY FORCEFUL AND FORTHRIGHT TERMS THAT GOU SHARES PUBLIC CONCERN AND WAS DETERMINED TO SPARE NO EFFORT IN SOLVING CRIME. EARLY CONFIRMING SIGNS ARE POLICE ASSIGNMENT TO CASE OF NARCOTICS DIVISION CHIEF CAPT. 1. POLICE CONTINUE ACTIVELY TO INVESTIGATE HEBER AND SAENZ MURDERS, AND TO PUBLICIZE LIMITED NEW DEVELOPMENTS AS THEY OCCUR. HOWEVER, LEADS REMAINS FEW, PROGRESS IS SLOW, AND THERE IS SCANT OPTIMISM FOR AN EARLY SOLUTION OF THESE CASES.

2. COMMENT: ALTHOUGH THE MANNER OF THESE TWO MURDERS IS STRIKINGLY DIFFERENT, AND NO LINKS BETWEEN THEM HAVE BEEN FIRMLY ESTABLISHED, DURING PAST TEN DAYS MONTEVIDEO HAS BEEN AWASH WITH RUMORS OF SUPPOSED NEW DEATHS, DEATH THREATS AND KIDNAPPINGS. THERE IS ALSO A THEORY, HIGHLY SPECULATIVE AT BEST AND BASED LARGELY ON CIRCUMSTANCE, THAT THE BLANCO LEADERSHIP MAY HAVE BEEN SINGLED OUT BECAUSE THEY WERE ACTUALLY AWARE OF ALVAREZ'S SUPPOSED PLAN, AND MA INDEED HAVE REACHED SOME SORT OF AGREEMENT WITH HIM OVER URUGUAY'S POLITICAL FUTURE.
